PETITION 18 Subject: Re-examine the Funding Paradigm

**Text:** Whereas, The Western North Carolina Annual Conference in 2004 passed a new funding paradigm which lists all program ministries as "FairShare Asking" items, meaning that it is no longer mandatory for the local churches to fund the program ministries from which they benefit and under which conference youth ministries are now listed; and

Whereas, Youth ministry, as well as other program ministries, has had its apportioned budgets cut 55% be-

cause of the *poor response* from the local churches to this new funding paradigm; and Whereas, Because of this severe financial cut, the Office of Ministries with Young People and other program-related ministries may no longer be able to provide some of the events (i.e., SpiritUs, SUMMIT, Choose2 Share Christ, Kaleidoscope, adult youth worker training, etc.) that have been provided in the past and are severely limited in their ability to assist local churches in their present and future ministries; and

Whereas, We have found that a large number of the local churches did not have the new funding paradigm explained comprehensively so that they could understand its far-reaching effects to their ministries and missions nor recognize what "Conference Benevolences and Program Ministries" encompasses; and Whereas, Conference youth events reach over 5,000 youth and adult youth workers each year; and Whereas. The vision of the Western North Carolina Conference is to focus on ministry and mission rather

than "maintenance," and the conference program ministries exist solely to support and enable the local churches to do more effective ministry and mission; therefore, be it

\*Resolved\*, That the Western North Carolina Conference of The United Methodist Church, in session June 9-

12, 2005, at Lake Junaluska, North Carolina, direct the conference Council on Finance and Administration to (a) re-examine the funding paradigm to look for ways of putting ministry and mission first and (b) present a new funding proposal to the 2006 annual conference session.

Resolved, That this process include at least two members of the program ministries staff and that a clear, understandable presentation be communicated to all the local churches.

PETITION 24 Subject: Rural Life Sunday
Text: Whereas, Paragraph 266.3 of *The Book of Discipline* (2004) states that:

Rural Life Sunday shall be observed on a date to be determined by the annual conference. Rural Life Sunday shall call the Church to celebrate the rural heritage of The United Methodist Church, to recognize the ongoing crisis occurring in rural areas of the nation and the world today, and to affirm the interdependence of rural and urban communities. The observance of Rural Life Sunday shall be under the general supervision of the General Board of Global Ministries. Anyone who desires to recommend a Rural Life Sunday theme for a given year may do so one year before the observance for which the recommendation is made. Recommendations are to be made to the General Board of Global Ministries, and the voting members of the board shall determine the annual theme of this Sunday.

And

Whereas, The rural crisis had led many rural residents of our country to suffer the loss of self-esteem and their way of life due to the closure of farms, businesses, schools, and health-care facilities; and Whereas, The state of North Carolina continues to suffer the loss of rural and open land; and

Whereas, The good citizens of North Carolina in rural and urban areas face growing environmental concerns about the quality of our land, water, and air due to what is commonly called "urban sprawl"; and

Whereas, Rural Life Sunday has traditionally promoted themes related to health and wholeness, conservation, and stewardship of our natural resources; and

Whereas, These themes are of increasing importance; and

Whereas, The Book of Discipline gives authority to the annual conference to set Rural Life Sunday on the date best for the annual conference; therefore, be it

Resolved, That the Western North Carolina Conference of The United Methodist Church designate the sixth Sunday after Easter, or another Sunday where needed, as Rural Life Sunday in 2006; urge the člergy and laity of its member congregations to observe this day, and encourage its member congregations to utilize resources for this observance from such sources as the General Board of Global Ministries, the United Methodist Rural Fellowship, the Rural Chaplains Association, and county Soil and Water Conservation offices located across the region

PETITION 25 Subject: Parsonage Furniture
Text: Whereas, The Western North Carolina Annual Conference of The United Methodist Church currently

mandates that parsonages, if provided by churches or charges, be mostly furnished; and
Whereas, Clergy are committed to following Jesus, who set the example of itinerant ministry and yet had two
locations that he called "home," both Nazareth and the town of Capernaum on the Sea of Galilee, from which
he called his 12 disciples (cf. Matthew 4, which tells us that, when Jesus left his childhood home of Nazareth, he "made his home in Capernaum by the Sea"); and

Whereas, "Home" is both a location and a sense of belonging; and Whereas, Clergy families need to feel a sense of "home," a sense of belonging and stability, in houses that are not their own; and

Whereas, In order for clergy families to achieve a better sense of "belonging," it is important for them to have their own "belongings," a word that means not only the items to which we become personally attached, but also the sense of security and memory that they provide us; and
Whereas, If the parsonage is, in fact, intended as a "home" for the clergy family, it must be a place where the

family can feel comfortable; and

Whereas, The quality and care of parsonage furnishings varies among churches, with some demonstrating such excessive attention as to make them decorator showplaces that are too formal to be usable, while others display such neglect and insensitivity as to make the parsonage unfit for healthy and dignified living; and

Whereas, The current policy of parsonage furnishings fosters an unhealthy dynamic of entitlement by clergy and paternalism by churches; and

Whereas, The intense interest and emotional investment often exhibited by churches in their parsonages conflict with the privacy that housing should afford for all persons; and

Whereas, The tastes and preferences of each clergy family are different and may be different from the tastes and preferences of parsonage committee members; and Whereas, The makeup of each clergy family is different, especially with regard to the number of children and

their ages and genders, so that the furniture needs of each family are different; and
Whereas, Churches and parsonage committees should not be expected to accommodate the unique needs

and preferences of every clergy family; and
Whereas, Clergy families should be afforded the same dignity of providing for their own needs that is avail-

able to non-clergy families; and

Whereas, A clergy person who is called to itinerant ministry as a second career already owns a full household of furniture that meets the needs of his or her family; and

Whereas, Clergy families should be allowed to own the type and style of furniture they need or want, without having to coordinate with existing parsonage furniture or negotiate storage issues; and

Whereas, The Parsonage Guidelines of the Western North Carolina Conference merely "recommend," rather than "require," that parsonage furniture be stored at the expense of the church (Section II.C.1); and

Whereas, Negotiations pertaining to the storage of parsonage furniture (Section II.C.3) have the potential to begin a clergy-congregation relationship with misunderstanding, hostility, and even resentment, especially in the case of "memorials or other gifts to the parsonage" (Section II.A.9); and

Whereas, It is more practical and financially responsible to purchase furniture as needed throughout one's adult life than to purchase an entire household of furniture upon leaving the itinerant system (retirement, extension-ministry appointment, etc.); and

Whereas, Not all churches own parsonages, and clergy families appointed to these churches must rent or purchase furniture, which places a financial burden on the families; and

Whereas, Serial use of upholstered furniture and bedding is unhygienic; and Whereas, The *Parsonage Guidelines of the Western North Carolina Conference* make no requirement pertaining to the quality or cleanliness of the furniture besides, "GOOD MATTRESSES AND BOX SPRINGS" (Section II.A.5), and, "Discarded furniture should not be put in the parsonage" (Section II.A.8); and

Whereas, The covenants of maintenance and cleanliness (Section VI.A.2-3 and Section VI.B.2) are too often ignored; that is, churches fail to provide furniture that is in good condition, and clergy families fail to maintain the quality of existing parsonage furniture; and
Whereas, The Western North Carolina Annual Conference reimburses a portion of a pastor's moving ex-

Whereas, The Western North Carolina Annual Conference reimburses a portion of a pastor's moving expenses and recommends that "Each church/charge receiving a new pastor [be] strongly urged to pay any out-of-pocket expenses incurred by the new pastor as a result of the move" (*Guidelines for Pastoral Transitions*, Western North Carolina Conference of The United Methodist Church, p. 37); and Whereas, The financial burden placed on churches by their paying moving expenses not covered by the conference would be comparable to the cost of properly maintaining the cleanliness of existing parsonage furniture (*i.e.*, steam-cleaning upholstery, purchasing new furniture to replace worn pieces, replacing or reconditional parts and the conference would be confirmed by confirmed the confirmed by confirmed the confirmed by confirmed the confirme

ing mattresses and box springs, etc.); and
Whereas, Non-reimbursed moving expenses can be deducted from a pastor¹s taxable income; now, therefore, be it

Resolved,

That, in the Western North Carolina Conference,

- Parsonages shall not contain furniture, except standard kitchen appliances.
- Parsonage carpets and walls shall be neutral colors and styles.
- Parsonage windows shall have only blinds or shades.
- That the Western North Carolina Conference establish and enforce more specific standards for basic cleanliness, safety, practicality, and comfort of parsonages.
- That, in order to determine what will become of existing parsonage furniture, information be sought from other annual conferences that have discontinued the practice of providing furniture in parsonages.

# PETITION 28 Subject: Adequate Health Care in North Carolina

Text: Whereas, The Book of Resolutions of The United Methodist Church (2004, p 306 reads: ""... as it is unconscionable that any human being should ever be denied access to adequate health care due to economic, racial, or class barriers ... and the Council of Bishops has endorsed the Universal Declaration for Human Rights which clearly claims health care as a right due to every world citizen"; and Whereas, The 2000 General Conference stated, "We seek a national health-care plan that serves and is

sensitive to the diversity of all people in the United States and its territories" (The Book of Resolutions, (2004),

p. 309); and
Whereas, In a similar concern for human dignity, the Constitution of North Carolina guarantees the benefits

of education to all its children; therefore, be it

Resolved. That the Western North Carolina Conference of The United Methodist Church join with other proponents to sponsor an amendment to the North Carolina Constitution that would guarantee adequate health care to all residents, regardless of circumstances

Resolved, That the conference secretary immediately e-mail the heads of both branches of the state legislature to notify them of this action.
