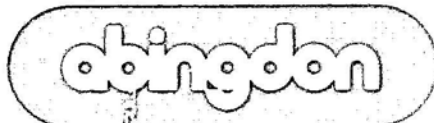
Major Black Religious Leaders 1755-1940
